4. First-aid measures

Inhalation

5. Fire-fighting measures

6. Accidental release measures

Personal precautions, protective equipment and emergency procedures

Methods and materials for containment and cleaning up

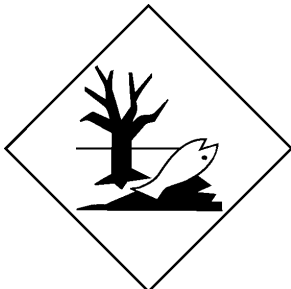
