

#### Section 4 - First Aid Measures

If On Skin: Thoroughly wash exposed area with soap and water remove contaminated clothing. If necessary, neutralize with lemon juice. Launder before reuse. Get medical attention.

#### Personal Precautions:

#### **Environmental Precautions:**

#### Methods for Cleaning Up Spills:

Small Spill: Absorb spilled product with absorbent material such as sand. If possible, vacuum spilled product into container. Dispose as directed by local regulatory norms.

Large Spill: Stop spill at source. Absorb spill with non combustible material or collect with vacuum pump. Keep away from heat and fire source. Provide adequate ventilation. Call authorities for assistance on disposal. Disposal should be made in accordance with federal, state, and local regulations.
